Hereby mutually agree to this Service Order (Effective Date) (“SERVICE ORDER”), in accordance with the following clauses and conditions:

CLAUSE 1 - PURPOSE

1.1. Once all conditions specified in Clause 6.2 of the AGREEMENT have been met, this SERVICE ORDER shall have the purpose of setting the AGREEMENT’s EFFECTIVE DATE, which shall be the signature date of this SERVICE ORDER, resulting in the CONCESSION TERM coming into effect.

CLAUSE 2 – TERM

2.1. The term of this SERVICE ORDER shall begin effective its signature date and terminate on the same date the AGREEMENT is terminated.

2.2. The term of this SERVICE ORDER may be amended as a consequence of amendments made to the CONCESSION TERM.

CLAUSE 3 – TERMINATION

3.1. This SERVICE ORDER shall be terminated due to the same termination events foreseen under the AGREEMENT.

3.2. Termination of this SERVICE ORDER shall lead to assigned grounds being immediately vacated and returned, under risk of the CONCESSIONAIRE being deemed an arbitrary possessor (guilty

of disseisin), for purposes of repossession of the property, pursuant to article 926 as well as the following articles of the Brazilian Civil Procedure Code, in addition to returning all equipment assigned, notwithstanding indemnities owed to the STATE OF SÃO PAULO, as the case may be.
